1. Name: The name of the institution shall be St. Martin's CHILDREN EDUCATION SOCIETY'S ST. MARTIN'S HIGH SCHOOL.
2. Location: The address of the school is Geethanagar, Ferroguda, Bownepally Post, Secunderabad. 500 011, A.P.
3. Admission: The School shall admit both boys and girls.
4. Membership: Membership is open to all who are interested in furthering the aims and objects of the Society.

1. The ~~Exec~~ Governing council shall consist of Eleven members.
2. There shall be no category members.
3. Admission fee and annual subscription for all.

GENERAL BODY:

- 1) Annual General body will meet once in a year, i.e. in the first week of June.
- 11) Functions:
 - a) To pass the budget for the ensuing year and to approve the expenditure statement for the previous year.
 - b) To approve the report of the activities of the Society.
 - c) To elect the Executive committee and nominate the Education committee.
 - d) To appoint ~~xxxx~~ an Auditor.
5. The Governing council shall be elected from the Executive committee of Eleven Members and shall consist of the following office bearers,
 - i) President.
 - ii) Vice President.
 - iii) Secretary and Correspondant.
 - iv) Treasurer.
 - v) Assistant Secretary.
6. The Governing council, its powers and duties etc.
 - i) The Governing Council shall be responsible for the management of and administration of the School. The tenure of Office of the Governing Council shall be Five Years.
 - ii) The Secretary shall convene meetings of the Governing Council atleast once in three months. He shall produce before the Council ~~xxxxxx~~ the report of the School, income and expenditure statements within 3 months at the end of the Financial year for approval of Governing Council. In the absence of the Secretary the Asst. Secretary shall have the powers to proceed accordingly failing which the President shall have the powers to do so.
 - iii) The President or the Secretary shall have to convene a meeting of the Governing Council, if any three members of the Governing Council send a written requisition for the same.

- iv) The quorum for the meeting of the Governing Council shall:
 (5) Five. If a meeting is adjourned for want of quorum an adjourned meeting shall transact business without any reference to quorum, provided a written notice is sent to all the members of the Governing Council.
- v) Ordinarily notice shall be given for holding a meeting of Governing Council three days in advance but for an extraordinary meeting (24) twenty Four hours notice shall be deemed sufficient.
- vi) For emergent matters, circular meetings could be conveyed.
- vii) All appointments shall be made and confirmed by the Governing Council.
- viii) There shall be an education committee to advise on the various methods to be adopted for teaching. The following shall be the members of the committee.
- Member of the Society as Chariman who is distinguished person in the field of education.
 - Two from the nominated members of the Governing Council, who are preferably connected with the educational field.
 - Vice-President of the Governing Council.
 - Secretary, (Ex-Officio)
 - Principal, (Ex-Officio)
- ix) The Governing Council shall approve the estimated budget and accounts with the Audit Report.

Funds: The funds shall be spent only to the attainment of the object of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.

7. BANKS:

- Current/ Savings account shall be opened in any bank or banks at Secunderabad and shall be jointly operated by any two of the Secretary, Assistant Secretary, President/Vice President.
- All the receipts shall be deposited in the Bank account and in no case more than Rs. 500/- be kept as cash in hand for the day to day expenditure.





RIGHTS AND DUTIES OF THE OFFICE BEARERS.

PRESIDENT:

- i) In addition to above, he shall preside over the meetings of the governing council and conduct the proceedings.
- ii) In case of emergency, he shall call a meeting of governing council in writing with 24 hours notice.
- iii) He shall advise in the matters relating to the school.

VICE -PRESIDENT:

In the absence of the President, the Vice-President shall all the powers of the President.

SECRETARY: ~~XXXXXXXXXXXXXXXXXXXX~~

- i) He shall be responsible to the governing council for all the matters relating to the school.
- ii) He shall convene meetings of the governing council.
- iii) He shall make necessary arrangements including full time or part time appointments in the school with consultation with the principal and the President, which shall be confirmed in the following meeting of the governing council.
- iv) He shall approve the expenditure as provided in the budget.
- v) He shall arrange to collect and receive all moneys including donations for the school and deposit in the bank account of the school within 48 hours.
- vi) He shall have the powers to negotiate any agrments for lease/rental/purchase/sale of any property for the benefit of the Society and shall execute the same on behalf of the society.
- vii) He shall act as correspondant.

ASSISTANT SECRETARY :

Besides helping the Secretary in his work, in his absence shall act as Secretary.

TREASURER :

- i) The Treasurer shall also maintain the accounts regulary and shall be in custody of the account books, vouchers etc., including the bank pass book and cheques books.
- ii) The Treasurer shall not pay out any amount exceeding sanction.
- iii) No action of the Treasurer shall be binding on the council or its members or member.
- iv) The Treasurer shall not credit any amount in his own account nor shall receive any money without issuing receipts therefor.

9. At the end of every academic year the accounts of the Society shall be audited by a Chartered Accountant appointed by the Governing Council.

10. St. Martin's Children Education Society shall be the sole owner of the immovable property etc., of the School.

11. The Constitution of the institution shall not be amended except by a resolution adopted by an extra ordinary General body meeting convened for the purpose, by Secretary, at which not less than 2/3rd of the members of the society are present and voting, provided that no such meeting shall be convened unless notice of the proposed amendment is given to all members atleast two weeks before the date of meeting. And Confirmed by 2/3rd of the members present at a second special meeting.

WINDING UP :

In case of the Society is to be wound up, the property and funds of the Society that shall remain after full satisfaction of the liabilities of the society, will be transferred or paid to some other institutions with similar aims and objects.
