The Authorized Signatory of Sri NS Srinivas S/o NPR Sharma, School Principal for M/s **St. Martin's High School.**, above 1<sup>st</sup> cited has requested for Traffic NOC to run M/s **St. Martin's High School**, Situated at H.No.13-69/1, Madhusudan Nagar, Malkajgiri, Medchal - Malkajgiri District. Accordingly the matter was referred to the ACP Malkajgiri Traffic Div, who submitted his report vide reference 2<sup>nd</sup> cited.

In view of the recommendation of the DCP Traffic vide report 2<sup>nd</sup> cited above, there is **No Objection** to run a School, subject to the following terms and conditions:-

- 1 The management should maintain the parking and play ground place neat and clean.
- 2 The School Management is instructed to erect parking boards, School Zone, Speed Limit signage as per norms.
- 3 The School management should appoint (02) Security guards and ensure that the security guards should guide the movement of the children to ensure road safety and transport at the time of school opening and closing and the P.E.T should monitor the security guards.
- 4 The management should not make any changes/constructions in the provided Parking area and Play Ground area.
- 5 The School management should ensure that the other which will come for pickup and dropping of students those vehicles should stop inside the school premises i.e., at parking place only.
- 6 The School management should provide C.C.T.V Cameras in the premises of the School.
- 7 They should have entry and exit gate.
- 8 The class room should not be on the road side.
- 9 Parking places should be earmarked.
- 10 Should not allow under-aged school children to drive the auto mobiles.
- 11 They should also erect parking boards inside the school premises for all taxi vehicles.
- 12 They should mark zebra crossing in front of their school.
- 13 Proper safety measures have to be taken while children are crossing the road.
- 14 There should not be caused any traffic obstruction to the regular traffic.
- 15 The manager should take all necessary precaution for the safety of their school students.
